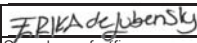

Contracts CAPP, C2AP, C3AP: Alternative Payment Programs are intended to serve two primary purposes: (1) enable low to moderate income families to work, pursue an education, seek employment and (2) improve the cognitive and educational development of children from said households. The Alternative Payment Program implements the guidelines issued by the California Department of Social Services to determine which families are eligible for a payment assistance voucher. Once a family is determined to be eligible for a voucher, Case Managers work with the family to connect them to child care. The Alternative Payment Program then reimburses the child care provider directly for the hours of eligible care authorized for the family. During FY 2022-2023, payment assistance was provided to 705 children and 469 families.

4b (Code:) (Expenses \$ 752,981. including grants of \$) (Revenue \$)

CDSS Stipends for CAPP, C2AP & C3AP: As part of the COVID-19 relief efforts and SB115 and AB179, the State of California supported child care by distributing several rounds of child care stipends (\$1,031-\$1,442 per enrolled subsidized child) which were distributed by CRC to child care providers serving families who receive subsidized child care. Stipends were meant to help providers with hardships caused by the pandemic such as reduced enrollment, increased teacher-to-child ratios, additional cleaning costs, and other costs.

4c (Code:) (Expenses \$ 533,265. including grants of \$) (Revenue \$)Quality Counts and Early Learning Programs:

Quality Counts provides information, resources, and coaching at no cost to early care and education programs, including centers, family child care homes and informal caregivers serving children ages 0-5. The program goal is to enhance the quality of learning programs and to recognize the effort of early childhood professionals to provide optimum learning environments and experiences for the children in our county. During 2022-2023, there were 47 sites participating in Quality Counts serving more than 3,366 children. See Schedule O for further details.

When a CalWORKS participant is eligible to receive child care services, a Stage 1 Authorization is sent to Community Resources for Children. CRC works with CalWORKS families to connect them to child care. The Alternative Payment Program then reimburses the child care provider directly for the hours of eligible care authorized for the family. During FY 2022-2023, CalWORKS payment assistance was provided to 82 children and 53 families.

Total program expenses were: \$449,434

Contract CRRP: The Child Care and Resource and Referral Program imparts information to parents about the full range of child care and early education options available to families. Parents/caregivers are provided with personalized child care referrals to licensed and license-exempt child care facilities within the county and receive counseling on how to choose a child care program, as well as additional information, such as on licensing requirements and parental rights. The program also offers outreach and technical assistance to child care providers, enabling them to access the various resources, trainings and grant opportunities available to them. In addition, our staff maintains data on the supply of and demand for child care in Napa County and supports outreach to the community about local child care issues and needs. In 2022-2023 the Resource and Referral program received 4,397 requests for child care referrals. Total program expenses were \$253,740.

Contract CCIP-Expansion: The CCIP-Expansion project/CC-Expansion project provides outreach, recruitment and support to prospective and new child care providers, with the goal to expand the supply of child care slots in Napa County. Stipends are offered to prospective providers to pay for costs associated with getting licensed. In 2022-2023, 21 providers received their family child care home license and opened their child care businesses. Total program expenses were \$211,501.

The BRIDGE program: provides child care vouchers, child care navigation services, and Trauma Informed Care Trainings to children that are Napa County dependents and their child care providers when a child is placed out of the home. Child Welfare Services determines family eligibility and sends Community Resources for Children referrals for BRIDGE eligible foster families, resource families, or relative caregivers. The BRIDGE program prioritizes streamlined enrollments, continuity of care between placements, and TIC resource availability to providers. In FY 2022-2023 the BRIDGE program served 13 children and 11 families. Total program expenses were \$106,122.

Instructional Materials and Supplies: Through this one-time grant, child care providers were able to purchase early learning materials to support their curriculum and environments. Total program expenses were \$45,720.

Total Small Projects other program expenses were \$30,617.

Contract CCIP: The Child Care Initiative Project delivers training to assist them in developing quality learning experiences and environments for children in their care. Trainings included best practices in education (such as infant/toddler care,

trauma-informed care, dual language learners, inclusion of children with special needs, anti-bias), business fundamentals training (Contracts & Policies, Communicating with Families), wellness and peer support groups, as well as CPR/First Aid Training. In 2022-2023, the Child Care Initiative Project provided training and support to 137 adults. Total program expenses were \$24,500.

Alternative Payment Program Capacity Grant & Child Care Providers United Support (CCPU): As part of the 2022 Budget Act signed by Governor Newsom, funding was allocated to support APPs in activities including but not limited to: enrolling families, accurate data collection, and reporting on ARPA Stabilization Grants. As part of the Child Care Provider Union Collective Bargaining Agreement, CDSS allocated funds to support APPs necessary work to be in compliance with all CCPU agreed upon requests including: dues deductions and data requests. Total program expenses were \$9,477

Contract CHST: The California Health and Safety Training program provides reimbursements to child care providers and prospective providers to cover the cost of required Preventative Health and Safety and CPR/First Aid training. Total program expenses were \$2,811.

Total Napa Valley Vintners other program expenses were \$1,779.

Quality Counts and Early Learning Programs:

Quality Counts provides information, resources, and coaching at no cost to early care and education programs, including centers, family child care homes and informal caregivers serving children ages 0-5. The program goal is to enhance the quality of learning programs and to recognize the effort of early childhood professionals to provide optimum learning environments and experiences for the children in our county. During 2022-2023, there were 47 sites participating in Quality Counts serving more than 3,366 children. Over the past year, participants of Quality Counts have developed quality improvement plans, received individualized coaching, accessed an array of free professional development trainings and been provided with incentives and materials to support quality learning environments.

The Toy Library and Early Learning Center provides a safe, enriching and inspiring venue for families and caregivers to seek advice about their child's development and access early learning resources to support their child's learning and developmental growth. Quality toys and early learning materials are available for loan at no cost to families and early childhood educators. CRC staff are available to provide developmental screenings using the ASQ-3/ASQ-SE and create Individual Development Support Plans that allow parents/caregivers to match their children's developmental needs with toys and materials. An annual No Sweet Trick or Treat Halloween event is also held every year in October which is open to the community. In 2022-2023, the Toy Library and Early Learning Center served 225 children and their 218 parents/caregivers.

Our early learning program offerings include bilingual playgroups and our Active Minds program. Through these programs, parents/caregivers are empowered as their child's first teacher through modeling and coaching from our staff to learn more about their child's stage of development, to engage their children in a way that increases skill development and to foster quality early learning experiences for their children. Parents/caregivers are also supported with resources and materials, such as books and activities, that they can use to continue extending learning at home. In 2022-2023, these programs served 104 children and their 94 parents/caregivers.

Total program expenses were \$533,265.
