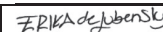

Contracts CAPP, C2AP, C3AP: Alternative Payment Programs are intended to serve two primary purposes: (1) enable low to moderate income families to work, pursue an education, seek employment and (2) improve the cognitive and educational development of children from said households. The Alternative Payment Program implements the guidelines issued by the California Department of Social Services to determine which families are eligible for a payment assistance voucher. Once a family is determined to be eligible for a voucher, Case Managers work with the family to connect them to child care. The Alternative Payment Program then reimburses the child care provider directly for the hours of eligible care authorized for the family. During FY 2023-2024, payment assistance was provided to 909 children in these programs.

Alternative Payment Program Capacity Grant & Child Care Providers United Support (CCPU): As part of the 2022 Budget Act signed by Governor Newsom, funding was allocated to support APPs in activities including but not limited to: enrolling families, accurate data collection, and reporting on ARPA Stabilization Grants. As part of the Child Care Provider Union Collective Bargaining Agreement, CDSS allocated funds to support APPs necessary work to be in compliance with all CCPU agreed upon requests including: dues deductions and data requests.

4c (Code:) (Expenses \$ 595,752. including grants of \$) (Revenue \$)

Contract Stage 1: Stage 1 or CalWORKS Program: CalWORKS' primary purpose is to enable eligible families to accomplish their approved activity, so they can become self-sufficient over the long-term. The Napa County Self-Sufficiency Division determines which families are eligible for a payment assistance voucher. When a CalWORKS participant is eligible to receive child care services, a Stage 1 Authorization is sent to Community Resources for Children. CRC works with CalWORKS families to connect them to child care. The Alternative Payment Program then reimburses the child care provider directly for the hours of eligible care authorized for the family. During FY 2023-2024, CalWORKS payment assistance was provided to 86 children.

CDSS Stipends and Transitional Stipends for BRIDGE, Stage 1, CAPP, C2AP & C3AP:
Transitional Payments were sent on behalf of CDSS and signed bill SB 140. SB 140
determined a flat-rate amount for all child care providers based on April 2023
payments to child care providers. Centers were paid \$3,000, large FCCHs were paid
\$3,000, small FCCHs were paid \$2,500, and license-exempt providers were paid \$500.
Implementation instructions can be located on CCB 23-32. Total expenses were
\$550,232.

Quality Counts and Early Learning Programs:

Quality Counts provides information, resources, and coaching to early care and
education programs, including centers, family child care homes and informal
caregivers serving children ages 0-5. The program goal is to enhance the quality of
child care programs and to recognize the efforts of early childhood professionals to
provide quality early learning and educational experiences to the children in our
county. During 2023-2024, there were 38 sites participating in Quality Counts
serving more than 565 children.

Participants of Quality Counts develop quality improvement plans, receive
individualized coaching, and have access to an array of free professional
development trainings. They are also provided with incentives and materials to
support their programs.

The Shared Services Pilot provided enhanced resources and funding to support family
child care home programs with developing or sustaining their food programs, connect

them with community services, as well as strengthening their financial and personal wellness. This one-time pilot served 4 family child care programs during 2023-2024.

The Toy Library and Early Learning Center provides a safe and enriching space for families and caregivers to seek resources and access early learning activities to support their child's learning and development. Educational toys and materials are available for loan at no cost to families and early childhood educators. An annual No Sweet Trick or Treat event is also held every year on Halloween that is open to the community. In 2023-2024, the Toy Library and Early Learning Center served 241 children and their 260 parents/caregivers. Our early learning program offerings include developmental screenings, bilingual playgroups and our Active Minds program. Staff provide developmental screenings using the ASQ-3/ASQ-SE Questionnaires and create personalized recommendations that allow parents/caregivers to support their child's specific developmental needs with materials and activities. While participating in playgroups and Active Minds, parents/caregivers are empowered as their child's first teacher through modeling and coaching from our staff to learn more about their child's stage of development, to expand their child's skills through engaging interactions and to foster quality early learning experiences for their children. Parents/caregivers are also supported with resources and materials, such as books and activities, that they can use to extend learning at home. In 2023-2024, these programs served 149 children and their 131 parents/caregivers.

The Child Care Expansion project supports prospective child care providers with starting their own child care businesses, with the goal to expand the supply of child care slots in Napa County. Prospective providers receive individualized coaching and resources from a licensing specialist to complete all of the training

and licensure requirements, as well as to establish their child care programs.

Stipends are awarded to those who successfully obtain their license. In 2023-2024, 13 providers received their family child care home license and opened their child care businesses.

Total expenses for these programs were \$504,964. Funding provided by Federal, State and local grants, private foundations, and individual contributions.

Contract CRRP: The Resource and Referral Program imparts information to parents about the full range of child care and early education options available to families. Parents/caregivers are provided with personalized child care referrals to licensed and license-exempt child care facilities within the county and receive counseling and resources on how to choose a child care program, licensing requirements and parental rights. The program also maintains data on the supply of and demand for child care in Napa County and provides technical assistance to existing and prospective child care programs. In 2023-2024 the Resource and Referral program received 3,052 requests for child care referrals. Total program expenses were \$267,552.

BRIDGE: The BRIDGE program provides child care vouchers, child care navigation services, and Trauma Informed Care Trainings to children that are Napa County dependents and their child care providers when a child is placed out of the home. Child Welfare Services determines family eligibility and sends Community Resources for Children referrals for BRIDGE eligible foster families, resource families, or relative caregivers. The BRIDGE program prioritizes streamlined enrollments, continuity of care between placements, and TIC resource availability to providers.

In FY 2023-2024 the BRIDGE program served 20 children. Total program expenses were \$117,994.

Contracts CCIP: Our staff provide professional development through the Child Care Initiative Project contract and other grants to early childhood educators, including those who work at centers, family child care homes and as informal caregivers. Trainings included best practices in education (such as infant/toddler care, trauma-informed care, inclusion of children with special needs, emergency preparedness), business fundamentals training (insurance, taxes and record-keeping), wellness and peer support groups. Stipends were also provided to 10 newly licensed providers who met certain eligibility criteria and completed our business fundamentals training program. In 2023-2024, we provided training and support to 117 adults. Total program expenses were \$48,555.

Total Small Projects other program expenses were \$18,926.

CHST: The California Health and Safety Training program provides reimbursements to current and prospective providers to cover the cost of required Preventative Health and Safety and CPR/First Aid training. In 2023-2024, 35 providers received funds. Total program expenses were \$4,766.

Total Napa Valley Vintners other program expenses were \$4,025.
